

**INSTRUCTION LETTER FOR THE CLAIMS PROCESS OF:
NURTURE RX LTD. – IN RECEIVERSHIP**

A. CLAIMS PROCESS

By Order of the Supreme Court of British Columbia made on January 30, 2024, (the “Claims Process Order”), the Court-appointed Receiver and Manager of Nurture RX Ltd., Derek L. Chase & Associates Ltd. (the “Receiver”), has been authorized to conduct a claims process (the “Claims Process”) with respect to claims against Nurture RX Ltd. in accordance with the terms of the Claims Process Order.

Unless otherwise defined, all capitalized terms used herein shall have the meanings given to those terms in the Claims Process Order.

The Claims Process Order governs all Claims related to Nurture RX Ltd.

This letter provides instructions for completing the Proof of Claim. Reference should be made to the Claims Process Order for a complete description of the Claims Process. The Claims Process is intended for any Person with any Claims against Nurture RX Ltd., whether liquidated, unliquidated, contingent or otherwise.

B. SUBMITTING A PROOF OF CLAIM

If you believe that you have a Claim against Nurture RX Ltd., you must file a Proof of Claim with the Receiver.

All Proofs of Claim must be received by the Receiver before 4:30 p.m. (Pacific Time) on March 12, 2024 (the “Claims Bar Date”).

PROOFS OF CLAIM MUST BE RECEIVED BY THE CLAIMS BAR DATE OR RESTRUCTURING PERIOD CLAIMS BAR DATE, AS APPLICABLE, OR THE APPLICABLE CLAIM WILL BE FOREVER BARRED AND EXTINGUISHED.

All Claims denominated in foreign currency shall be converted to Canadian dollars at the Bank of Canada daily average exchange rate on March 12, 2024.
